Correspondence

RCCP – The proposal for Grassland for Gamebirds & Songbirds (GGS), was selected for funding in its entirety. That means it the proposal should receive \$1 million dollars to help implement the initiative. The total budge of the initiative is \$1.833 million. That includes RCPPP funding as well as partner contributions. That budget will finance: the hiring of 3 fulltime grassland biologist positions, development of grassland and pollinator habitat throughout 5 focal regions of Indiana, and implementation of conservation work to conserve and access habitats to important grassland bird species such as the bobwhite quail, ring-necked pheasant, loggerhead shrike, and henslow sparrow.

<u>IANA -</u> NRCS & Indiana Farm Bureau have formed a new non-profit called the Indiana Agriculture Nutrient Alliance. The alliance was formed because they realize that commodity partners like Farm Bureau, along with corn and soybean alliances and livestock groups reach many more farmers than NRCS does. This alliance is formed to reach more farmers throughout the state.

<u>Thank you –</u> Jane Hardisty sent an email to Kelly and asked that she share it with the board of supervisors. At her Nov. retirement party held at the SE area meeting in November she was grateful to the district staff for the food and that Jerry St. John and Brad Ponsler took time to stop by and wish her well.

<u>Rural – Urban –</u> Jerry St. John made a motion to continue a sponsorship of this event at \$250 with a second from Matt Branham.

<u>Plain Dealer – Matt Branham made a motion to continue the district subscription to the N.V. Plain</u> Dealer & Sun. They have been a great supporter of the SWCD for many years and with the Share Some Space campaign. A second was made by Tom Schneider.

<u>Crop Production Workshop – The board opted not to sponsor this event.</u>

<u>SEI –</u> Our agreement is up May 1, 2018 and the new rates will be, Domain Registration is \$15.95/year and Domain Hosting is \$4.95/month. A motion was made by Jerry St. John to set this up on an annual basis, with a second by Matt Branham.
